### **CORRESPONDING FORM ETA INFORMATION:**

Enter the reference number given to you by the NACRS representative you contacted and who handled your order same as first entered in item 14e of Form ETA.

Enter the first initial and last name of the representative who issued you the reference number and handled your order same as first entered in item 14f of Form ETA.

### **ADDITIONAL TRUSTEE'S INFORMATION:**

Enter the item number in space between the brackets. If this is the first or only Form ETAad1 attached to Form ETA then the first item number will be "4" a continuation from item 3 on Form ETA. All items after this will be number in ascending order (e.g.: "5" "6" "7" and so on).

If this is the second or later Form ETAad1 attached to Form ETA then the first item number will be the next consecutive number after the last item number of the preceding Form ETAad1 (e.g.: if last item number on preceding Form ETAad1 was "11" then the first item number of this Form ETAad1 will be "12").

Enter only one Trustee's name. Spell legal name in True Name form (upper and lower case) as it is crucial to the identifying of the parties to the trust instruments.

If Trustee is an organization enter full legal name of Organization and include its suffix in box marked "prefix". Include the mailing address of the Trustee. This must be a physical address as UPS and FedEx do not deliver to P.O. Boxes.
